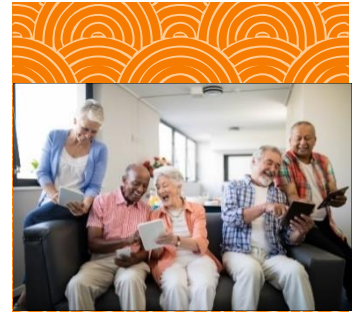
## Aging Matters – Taking Control Against Fraud: Building Awareness to Use Technology Safely
